Scope of this document

This document is a report of activities linked to ACTRIS IMP task 1.3 named "Maintaining and enlarging country participation and membership in ACTRIS". As the name and description of the ACTRIS IMP task 1.3 indicate, the focus is on the country level participation and in the country level (interim) governance bodies and advisory bodies linked to them. This focus is also in line with the short description of the deliverable in the ACTRIS IMP grant data. At the starting time of ACTRIS IMP the involved countries had approved ACTRIS ERIC step 1 documents to be sent, but none of the countries had signed a long-term commitment for ACTRIS, which comes through membership in ACTRIS ERIC. Therefore, the focus of ACTRIS IMP task 1.3 (and therefore also this deliverable) was the work towards getting the participating countries to join ACTRIS ERIC.

Most of the work towards getting the countries in as members of ACTRIS ERIC took place within the interim governance and advisory bodies, especially the Interim ACTRIS Council, and in preparation of materials for them. These were the bodies that defined the rights and commitments of the ACTRIS ERIC member countries, and the representatives in the bodies had a mandate to speak on behalf of their countries. These bodies and their activities are described and reported in this deliverable. The Countries not participating at ministry or funding organization level but participating in ACTRIS IMP through research performing organizations are also listed in the document and their status reported in regard of potential membership at the time of original submission of the deliverable.

As the aim of this work in ACTRIS IMP was to get the countries to join ACTRIS ERIC, a logical timeframe to be reported is from beginning of ACTRIS IMP in January 2020 until the establishment of ACTRIS ERIC in April 2023 and the first ACTRIS ERIC General Assembly meeting of ACTRIS ERIC in June 2023. Activities of the same or equivalent bodies after the establishment of ACTRIS ERIC are generally not considered here. As some of the main bodies have worked continuously from the beginning of ACTRIS PPP project in 2017 their activities are reported also from the years preceding ACTRIS IMP.

The country level governance and advisory bodies presented in this document are:

The bodies not included in this deliverable and their activities were needed for scientific development and day-to-day management of ACTRIS and the ACTRIS IMP project. They were necessary for preparing materials for and implementing the decisions of the country level bodies but did not directly contribute to maintaining or enlarging of country level participation in ACTRIS. The work done nationally in each country is reported in deliverable 1.1 "Report on national ACTRIS consortia" and the engagement activities with scientific communities in countries inside and outside the ACTRIS ERIC are reported in deliverable 1.2 "Report on enhancement of community building". These also include any bilateral meetings between ACTRIS Head Office and the national scientific communities focusing on getting the respective ministries more involved in ACTRIS.

Interim ACTRIS Council (IAC)

Task and main milestones of IAC

The Interim ACTRIS Council (IAC) was the highest decision-making body for ACTRIS as a research infrastructure prior to ERIC was established. The IAC consisted of country representatives nominated by the ministries or organisations mandated to act on the behalf of the country, including financial commitments. Each participating country could nominate up to three delegates and two experts to represent the country in the meetings. The IAC was responsible for negotiating and approving the legal model, governance structure, statutes and all other necessary constitutional documents, Financial Plan and Internal Financial Rules, as well as all policy documents such as data policy, access policy, and staff policy for ACTRIS. The documents approved by IAC and later ACTRIS ERIC General Assembly (GA) are available on the ACTRIS web pages at https://www.actris.eu/documents/approved-documents.

For enabling efficient work of the IAC it is crucial that the provided materials are clear and well prepared and that it is clear what is expected from IAC. The materials were provided to IAC by ACTRIS interim Head Office and prepared together with the RI committee, Central Facility MBs and other day-to-day management bodies, often within the framework of the ACTRIS IMP project.

Interim ACTRIS Council held its first meeting in February 2017 in Helsinki. From then on IAC has convened two to five times a year. The main outcome of the IAC work has been the establishment of ACTRIS ERIC, after which the ACTRIS ERIC General Assembly has continued and will continue as the highest decision-making body in ACTRIS. The timeline for establishment of ACTRIS ERIC is presented in table 1 below.

Countries in IAC during ACTRIS IMP

ACTRIS IMP started soon after IAC received the commission feedback on the ERIC Step 1 documents. In ERIC step 1 there were 16 countries stating to be prospective members of ACTRIS ERIC:




Figure 1: Countries committed in ERIC application Step 1.

At the time of signing the commitment letters for ACTRIS ERIC Step 1 United Kingdom was also represented in the IAC but could not commit for Step 1 due to its uncertain status related to Brexit.

Between the ACTRIS ERIC Step 1 submission and the submission of Step 2 documents, two new countries joined IAC. They were Denmark (in 16th IAC meeting in June 2021) and Sweden (in 18th IAC meeting in March 2022).

The countries that signed a commitment letter for the ERIC Step 2 application and thus become the founding members of ACTRIS ERIC were:




Figure 2: Countries committed in ERIC application Step 2.

Kingdom of Netherlands joined ACTRIS ERIC in the first General Assembly meeting. Greece and The United Kingdom were also represented in IAC but were not yet able to commit to membership of ACTRIS ERIC at the time of its establishment and the first GA meeting. It is, however, expected that they will also join ACTRIS ERIC in near future. It is also to be noted that Switzerland is not a member but a permanent observer in ACTRIS ERIC due to its position outside the European Union and the related ERIC regulation.

Other interested countries

Besides the countries represented in IAC there have been three more countries participating in the ACTRIS implementation project. These countries are Estonia, Ireland, and Portugal. In these three countries the national ACTRIS-related research communities are organised and they have nominated national contact persons in ACTRIS at the scientific level. However, the support for ACTRIS in these countries have so far not been enough to get the ministries and funding organisations to formally participate in ACTRIS. This might change in the future if the national ACTRIS consortia manage to get ACTRIS on the national RI roadmaps, which often is a requirement for ministry level commitment. ACTRIS (interim) Head Office has held several meetings with the related scientific communities and national contact persons of these countries and provided support letters to enhance the formal participation process eventually leading to the countries to join ACTRIS ERIC. These meetings are not listed here but in ACTRIS IMP deliverable 1.2 "Report on enhancement of community building".

List of IAC meetings and main outcomes

From the establishment of IAC in 2017 to the official establishment of ACTRIS ERIC and its GA in 2023 the IAC has had altogether 19 meetings, of which the last 10 have taken place during the ACTRIS IMP project. Out of these 19 meetings the first 10 have been physical meetings and the remaining 9 virtual meetings, the latter mostly during the Covid-19 pandemic and the related travel restrictions. In the 19 meetings IAC were presented 218 meeting documents and 42 background documents, consisting of a total of 2537 pages of meeting material and 2094 pages of background material.

Scientific and Implementation Advisory Board (SIAB)

Objectives of SIAB

The objective of the Interim Scientific and Implementation Advisory Board (Interim SIAB) has been to advise and support the Interim ACTRIS Council (IAC) and the ACTRIS community in their implementation work to obtain the objectives of ACTRIS, and in developing services, interactions with user communities, and liaison with partners and stakeholders. The interim SIAB has advised on the overall ACTRIS technical plans and directions and followed the implementation and establishment of the ACTRIS legal entity (ACTRIS ERIC). It has provided feedback and recommendations on the further development of ACTRIS research infrastructure strategies, services, and operations.

The Interim SIAB became officially Scientific and Innovation Advisory Board (SIAB) upon the ACTRIS ERIC establishment in April 2023. SIAB continues to advise on matters related to ACTRIS implementation until ACTRIS is fully implemented, foreseen to happen in 2026. While SIAB continues as the advisory body of ACTRIS IMP until the end of the project, upon the establishment of ACTRIS ERIC, SIAB also became the advisory body of the ACTRIS ERIC General Assembly.

Vincent-Henri Peuch (Head of the Copernicus Atmosphere Monitoring Service (CAMS), Deputy Director of the Copernicus Department at ECMWF),

Anna Maria Johansson (Retired from European Commission, DG Research and Innovation, Research Programme Officer during years 2001 – 2019) and

Oksana Tarasova (Head, Atmospheric Environment Research Division, World Meteorological Organization (WMO), previously Head of the Global Atmosphere Watch (GAW) Programme of WMO).

During ACTRIS IMP the Interim ACTRIS Council nominated three new (Interim) SIAB members and two of the previous (Interim) SIAB members have stepped down.

Interim ACTRIS Council gave in their 9th meeting (November 2019, Warsaw, Poland) a mandate to ACTRIS PPP / ACTRIS IMP to seek 2–3 additional (Interim) members to reinforce the SIAB. IAC nominated two new (Interim) SIAB members proposed by ACTRIS countries in their 10th meeting (February 2020, Brussels, Belgium): Anna Maria Johansson (European Commission, DG Research and Innovation, retired) and Vincent Henri Peuch (Copernicus CAMS).

In autumn 2020, previous ACTRIS (Interim) SIAB member **Beatrix Vierkorn-Rudolph** (Chair of the ESS (European Spallation Source) Council) stepped down from SIAB due to other commitments.

In autumn 2021, previous ACTRIS (Interim) SIAB member **Petteri Taalas** (Secretary General of World Meteorological Organization (WMO)) had to withdraw from his SIAB role due to other commitments. Dr. Oksana Tarasova (WMO) was nominated by IAC (18th IAC meeting, March 2022, virtual) as a new (Interim) SIAB member to replace Petteri Taalas in the (Interim) SIAB. She was proposed by the WMO.

SIAB meetings

ACTRIS Interim SIAB was originally established in 2018 during the ACTRIS PPP project and had four meetings before the start of ACTRIS IMP. During ACTRIS IMP but prior to the establishment of ACTRIS ERIC the Interim SIAB has convened an additional four times. All Interim SIAB meetings are listed below:

- 2nd SIAB meeting in 9/2018 during ACTRIS project week (Prague, Czech Republic) (During ACTRIS PPP)

- 4th SIAB meeting in 11/2019 during ACTRIS PPP meeting (Helsinki, Finland) (During ACTRIS PPP)
- 5th SIAB meeting in 3/2020 during the ACTRIS community week / ACTRIS IMP Kick-Off meeting (Larnaca, Cyprus), (During ACTRIS IMP)
- 6th SIAB meeting in 11/2020 (virtual meeting dedicated for SIAB), (During ACTRIS IMP)
- 7th SIAB meeting in 10/2021 during ACTRIS Week 2021 (virtual meeting), (During ACTRIS IMP)
- 8th SIAB meeting in 10/2022 during ACTRIS Week 2022 (Prague, Czech Republic), (During ACTRIS IMP)

Interim SIAB meetings have consisted of an introductory part where the Interim ACTRIS leader, ACTRIS Scientific Chair and other key persons from ACTRIS have presented the current implementation activities and plans to the SIAB, followed by a SIAB internal meeting. After the meeting, SIAB provided its observations, feedback, and recommendations to the ACTRIS Community in the form of a presentation at a physical or virtual meeting and a written report to the IAC. The Interim ACTRIS leader presented the SIAB reports to the IAC.

The Interim SIAB has acknowledged the remarkable progress of the ACTRIS IMP coordinators and community in establishing ACTRIS -ERIC, the added value of ACTRIS illustrated via several EU projects

(ACTRIS IMP, ENVRI-FAIR, ATMO-ACCESS, ACTRIS-CAMS, RI-URBANS, KADI etc.) and ACTRIS response to COVID related issues e.g., by providing expertise on aerosol transmission, simulation chambers and equipment/expertise to test COVID masks manufactured in Europe and studying the effects of COVID on European and global air quality. The Interim SIAB has provided valuable feedback and recommendations regarding ACTRIS implementation e.g., the development of the ACTRIS Business plan, ACTRIS partnership liaisons plan, ACTRIS effectiveness in the landscape (projects and/or international networks/organizations), ACTRIS ERIC strategy and innovation strategy. The Interim SIAB has also recommended ACTRIS to strive for efficiencies that help give added value to the activities of member institutions while avoiding undue managerial burden on leaders and scientists.

Other governance bodies

Financial committee

The Financial committee Terms of Reference was initially approved in the 17th Interim ACTRIS Council meeting in November 2022 and later in the first General Assembly. The nomination process for the members was started in February 2023. The members were selected in the first General Assembly meeting. The General Assembly decided to add members to the committee, and therefore an additional nomination process was started in August 2023. The additional members will be selected for the committee in the 2⁻⁻ General Assembly meeting.

Ethical advisory board

The Ethical Advisory board was not established in the implementation phase before the establishment of ACTRIS ERIC. The Ethical Board Terms of Reference was approved in the first General Assembly meeting of ACTRIS ERIC. The Ethical Advisory board nomination process was started in August 2023 and the members will be selected in the 2^{-1} General Assembly meeting.
